#### MEMO TO ALL POLITICAL PARTIES

This note is to inform you of recent changes to the list of eligible parties, and the effect of this on the allocation of paid and free time under the Canada Elections Act.

My last allocation of paid time was made on December 22, 1999, and it allocated 390 minutes between 10 registered parties and 2 eligible parties.

Since that time, a new eligible party has been added, namely, the Marijuana Party which became an eligible party on September 19, 2000.

However, one of the existing eligible parties, the Rest of Canada (ROC) Party has withdrawn its application for registration and as of October 18, 2000, it is no longer eligible.

The Canada Elections Act requires me to contact the parties for the purpose of reallocating the 6 minutes originally allocated to the Rest of Canada (ROC) Party. However, given the fact that another eligible party has been added, with the same statutory entitlement of 6 minutes, I have determined that the most practical approach is simply to reallocate the 6 minutes from the Rest of Canada (ROC) Party to the Marijuana Party. This will then avoid the necessity of having a total allocation that exceeds 390 minutes, and all other allocations will stay the same as in my December 22, 1999 order.

The resulting allocation of paid time is therefore as attached in Schedule A. The effect of this on the free time allocation is attached as Schedule B.

I propose to incorporate these numbers in my Guidelines to be issued if and when a federal general election is called.
