



When to use this form

This form is used throughout the year to report changes to the information about a registered association, its officers, agents and auditor in the Registry of Electoral District Associations. It must be submitted to Elections Canada within 30 days after there is a change in the information.

This form consists of the following parts:

- Part 1 Association's information and chief executive officer's certification
- Part 2 Chief executive officer's information
- Part 3 Financial agent's information
- Part 4 Auditor's information
- Part 5 Association officers' information
- Part 6 Electoral district agents' information

Important reminders

- If you are using a standard PDF reader, the information entered in the form cannot be saved. Be sure to print all completed
 pages before closing the document.
- Make sure the completed form is signed by hand and dated.
- Incomplete or illegible information may delay the processing of your submission.

Tips for completing the form

Parts 1 to 6

- Part 1, Section A, must be completed. Section C must be signed by the chief executive officer, certifying the changes in the registry information.
- For the rest of the form, complete only the parts with changes.

- Partnership of which every partner is a member in good standing with a provincial or territorial governing body of chartered professional accountants (CPA designation)*

Not eligible to be an auditor:

- · Candidate** or official agent
- · Election officer or member of the staff of a returning officer
- · Chief agent of a registered party or an eligible party
- · Registered agent of a registered party
- · Financial agent or electoral district agent of a registered association
- · Leadership contestant**, their financial agent or a leadership campaign agent
- Nomination contestant** or their financial agent
- · Financial agent of a registered third party

*Provincially or territorially legislated accounting bodies may require auditors to meet other professional criteria in order to perform this role, such as holding a public accounting licence in the province or territory where the political entity is based.

**A candidate, nomination contestant or leadership contestant continues to be a candidate or contestant after the election or contest period, until they have fulfilled their reporting obligations (for example, after they have paid their claims and loans, disposed of surplus and closed the bank account).

I am aware of the duties and responsibilities of this position under the Canada Elections Act, and I am eligible to act as an auditor under that Act. I am aware that it is an offence to knowingly act in this position while ineligible.
