



When to use this form

This form is used once a year to confirm the validity of the registered association's information in the Registry of Electoral District Associations or to report changes. It must be submitted to Elections Canada **by May 31** every year.

This form consists of the following parts:

- Part 1 – Confirmation of association's information and chief executive officer's certification
- Part 2 – Association's and chief executive officer's information
- Part 3 – Financial agent's information
- Part 4 – Auditor's information
- Part 5 – Association officers' information
- Part 6 – Electoral district agents' information

Important reminders

- If you are using a standard PDF reader, the information entered in the form cannot be saved. Be sure to print all completed pages before closing the document.
- Make sure the completed form is signed by hand and dated.
- Incomplete or illegible information may delay the processing of your submission.

Part 1

Complete all sections. The chief executive officer must sign Section C.

Parts 2 to 6

If there are no changes to report, click on the circle in the first field. If there are changes, complete the relevant sections.

**Provincially or territorially legislated accounting bodies may require auditors to meet other professional criteria in order to perform this role, such as holding a public accounting licence in the province or territory where the political entity is based.*

***A candidate, nomination contestant or leadership contestant continues to be a candidate or contestant after the election or contest period, until they have fulfilled their reporting obligations (for example, after they have paid their claims and loans, disposed of surplus and closed the bank account).*
